WHEREAS, Victoria, utilizing his passion for libations and building community, played an intricate role in the formation/development of the SFSU Academics Wine Club, which many faculty and staff still enjoy today; and

WHEREAS, his colleagues from around the campus community hold Victoria in high esteem for the kindness, commitment, care and joy he brought to his interactions with them;
