Resolution of the Board of Directors of The University Corporation, San Francisco State Honoring Jason Porth on the Occasion of his Retirement

WHEREAS, Jason Porth served the San Francisco State University community for over 18 years working in a variety of positions and most recently held a dual role as the Vice President of University Enterprises – consisting of The University Corporation, SF State Capital Planning, Design and Construction, Sustainability, Real Estate Development, and Downtown Campus Operations – and as the Executive Director of The University Corporation, SF State; and

WHEREAS, Jason Porth retired from the University on March 8, 2024 after a distinguished career of service to the campus community; and

WHEREAS, Jason Porth demonstrated both a love for the campus community and a commitment to service, most notably the gracious, thoughtful, and supportive way that he was able to build relationships with his colleagues across the campus and those he served; and

WHEREAS, during his tenure with the University, Jason ensured the success of a variety of important and meaningful projects that improved the campus community and enriched the lives of students, staff, members of the faculty, and those within the greater community:

- Oversaw the completion of Manzanita Square by leading efforts in securing the agreement with a developer for a public private partnership (P3) to building a state-of-the-art housing project and commercial space;
- Spearheading the life safety measures to keep Sierra Nevada Field Campus open and thriving;
- Oversaw the new Science Building and Marcus Hall planning and construction and new housing to increase on campus student housing;
- Oversaw improved vendor relationships and bringing new vendors to campus.
- Spearheaded the creation and implementation of the Gator Pass- a transit pass that gives free and discounted rides for our students.
- Oversaw the establishment of a formal institutional governance structure for the UCorp investment program.
- Led the Faculty and Staff Housing Taskforce and helped explore options leading to potential affordable housing solutions in the near future.
